

Terms and conditions:

- 1. The Interview/examination for the above posts will be conducted through in-person at ICAR-IIVR, Varanasi.
- 2. The number of positions may increase/decrease according to the need and availability of fund in particular scheme and may be enter changeable within different group with the consent of concerned In-charge/Officer's and finally approval of the Director.
- 3. Only Indian citizens are eligible for appearing in the online/ in-person interview.
- 4. Age limit: Minimum 21 years and maximum 45 years for RA, JRF, SRF, YP.I, and Semi Skilled Labour as on last date of submission of application with relaxation as per rules.
- 5. Period of contract service initially for one year whichever is earlier subject to requirement of the services of the contractual post i.e. RA, JRF, SRF, YP.I, & Semi Skilled Labour in the organization and satisfactory performance of the candidate after evaluation by Director.
- The above position is purely temporary basis and co-terminus with the project subject to satisfactory performance. The selected candidate shall have no right/claim for regular appointment or absorption at ICAR/ICAR-IIVR at any point of time.
- 7. No TA/DA and official accommodations will be paid /provided for appearing in the interview.
- 8. Only the candidates having essential qualification will only be considered for interview/written test.
- 9. Candidates are requested to ensure their eligibility like age, qualification etc. before appearing for the interview.
- 10. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.

11. Person already in employment should submit "No objection Certificate" from their present employer.

12. Application should be submitted by the candidates in the prescribe Proforma only. The entire desired document should be attached in the sequence as given in check list and check list should be duly filled as per given table in the application form. Applications if not found in proper Proforma along with desired documents as per check list may likely to be rejected.

- 13. Weightage of marks for selection: For selection of the candidate for RA, JRF, SRF, YP.I, (50 marks Academic, 25 marks Written and 25 marks Interview, if the candidates are 10 or below 10, the Selection Committee has power to select candidate on the basis of only academic 50 marks and interview 50 marks. For selection of YP I and Semi Skilled Labour (50 marks Academic and 50 marks Interview).
- 14. The RA, JRF, SRF, YP.I, & Semi Skilled Labour who have earlier worked in the ICAR schemes may be given preference for engagement subject to their suitability.
- 15. All eligible candidates are requested to be present 60 minutes before reporting time on the date of in-person interview for necessary formalities and verification of documents.
- 16. Original documents of the candidates appearing interview in-person will be verified on the date of interview. If found incorrect his/her candidature will be cancelled.
- 17. Selected Candidate will be required to produce all original documents at the time of joining for verification purpose.
- 18. The selected candidate will be required to produce medical certificate at the time of joining.
- 19. The Director reserves the right to cancel /postpone the interview without assigning any reason thereof.
- 20. The decision of the Director, ICAR-IIVR, Varanasi will be final and binding on all aspects.
- 21. The Director shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the project for which no appeal thereof shall be made.
